PLEX-F is an innovative crypto investment that includes the gasless holder yield (frictionless yield) feature and loyalty rewards additions. In fact, a certain percentage of deductions are taken from each on-chain transaction and this amount is automatically reflected in the balances of the investors who hold the token at the time the transaction is made. Thanks to this approach, investors can earn yields by simply holding their tokens without staking them.

However, **this feature alone does not constitute a market innovation**, so additionally, PLEX-F offers investors the possibility to earn loyalty rewards for safely holding their investments for long periods (at least six months), while protecting those same investments through automatic liquidity mechanisms and a monetary policy that mitigates speculative actions.

The most important for the investor is to keep in mind that **PLEX-F is not an old recipe of speculative investment**. As matter of fact, PLEX-F must be seen as a safe investment and fundraising platform, where everyone basically has the opportunity to invest in projects with high disruptive potential, which in turn can provide additional profits for investors. In summary, the main and long-term objective of the platform is to raise funds on an ongoing basis to invest in the development of innovative projects supported by Symplexia Labs.

Full Range of Features

REVOLUTIONARY DESIGN

Based on intensive research, PLEX-F features a comprehensive set of features that can be considered the best on the market, although some of these features may seem at first glance conceptually equivalent to less sophisticated features previously adopted by some alternatives in the cryptocurrency market.



Passive Income

PLEX-F works by applying a 4.5% fee to each buying transaction and 2.0% fee to each selling transaction, splitting instantly that fee among all holders of the token.

Holders do not need to stake or wait for fees to be delivered. Fees are awarded automatically and are immediately reflected in the holder's balance.



Loyalty Rewards

PLEX-F applies a variable fee of an average of 1% to each selling transaction, in order to compose a *Loyalty-Reward Fund* that is shared among holders who hold their tokens for at least six months.

The PLEX-F platform provides a method where investors can reclaim their loyalty reward at their convenience once the entitlement has been acquired.



Insurance

PLEX-F applies a 0.5% fee to each selling transaction, in order to compose a *Contingency Fund* to cover any security risks arising from misuse of the platform by malicious traders.

Additionally, the platform offers the Treasury Analyst the possibility of temporary suspension for analysis of accounts activities considered suspicious of malicious trading.



Project Funding

PLEX-F applies a fee of 2% to each buying transaction and 1% to each selling transaction, in order to compose a *Project Fund* to support the incubation and development of innovative solutions by **Symplexia Labs**, thus basically everyone has the opportunity to be a partner in initiatives with high disruptive potential, which in turn can provide additional profits for investors in the future.

Despite significant price appreciation, returns on crypto assets are not as impressive when adjusted for volatility, so to partially address this issue, PLEX-F was designed as a multi-reflection token that provides additional returns by applying fees to each transaction and instantly dividing that fee among all token holders. In addition, it presents an additional source of income through the “Loyalty Rewards” program, for investors who hold their tokens longer.

But what is most relevant in the complementary income generation strategy is that approximately 10% of the tokens, stored in the “Corporate Assets” wallet, will be backed by shares of Symplexia Labs. Thus, these tokens will offer dividend payments, in the same way that shareholders receive dividends, whenever Symplexia’s projects present positive financial results. Dividends will normally be paid semi-annually, from the transfer of part of the values from the “Corporate Assets” wallet to the “Golden Bonus” wallet, thus automatically being available to all token holders.



Regulatory Mechanisms **SPECULATIVE BUBBLE PROTECTION**

Nowadays the regular investors' main fear is how cryptocurrency speculators, in particular the 'whales', create valuation bubbles that almost inevitably burst, damaging all possible investment strategy.

To solve this problem, Symplexia Labs focused on the development of a “regulatory mechanism”, composed of: a “*Regulatory Fund*” (5% of Total Supply), a “*Fisher Attenuation*” method (prevents currency overvaluation during peaks of purchases), an automatic liquidity pool, a special deflationary method (Wicksell Burn) and, in addition, a dynamic fee calculation method (getDynamicFee), which penalizes any speculative movement.



Making Easy to Get Onboard **INNOVATIVE LIQUIDITY LANDSCAPE**

“ALLOWS EASY SWAP PROCESS AND REDUCE RISK OF WASHOUT”

It's largely known that a bigger *Liquidity Pool* in general offer more stability to the token price, ensuring traders can always Buy & Sell without liquidity issues. Thus, PLEX-F applies a 3% fee to each selling transaction, accumulating this fee in the contract, whose values are automatically transferred to the *Liquidity Pool* whenever the sum of the accrued fees is more than 0.5% of the total supply.

Additionally, an anti-whale mechanism ensures that whenever the difference between the sum of sellings and buyings is greater than 10% of the PLEX-F balance in the Liquidity Pool a trigger is activated, allowing our *Treasury Analyst* to execute the “*Fisher Attenuation*” method, which, using the *Regulatory Fund*, increases the asset's liquidity, thus creating a more stable price base.

Supply Adjustment Mechanisms

PRICE IMBALANCE PROTECTION

“SUPPLY MANAGEMENT MODEL THAT ENABLES GREATER INVESTMENT STABILITY”

The PLEX-F features a *"Deflationary Strategy"* based on two complementary burn mechanisms. Every selling transaction triggers a dynamic fee calculation method (`_getDynamicFee`) that establishes the percentages for the *"Deflation Fee"*, *"Delayed Burn Fee"* and *"Loyalty Rewards Fee"*. The amount referring to the deflation fee is burned automatically during the transaction, thus reducing the token supply. The value referring to the delayed burn fee is stored in a special reserve fund (`wicksellReserves`) to be manually burned by the Treasury Analyst at a later chosen date.

Ideally, the Treasury Analyst should trigger the burn method (`WicksellBurn`) every 90 days so as to effectively burn the tokens stored in the *"Wicksell Reserves"* wallet, in order to make the token price more attractive.

Investors are also offered a method for manually burning their tokens (*InvestorBurn*), however this burning has no immediate effect on the token supply. In fact, when the investor activates this method, 20% of the amount informed goes to the *"Loyalty Rewards"* wallet and 80% is credited to the *"Wicksell Reserves"* wallet to be burned manually afterwards.

Altogether, those mechanisms generate a controlled scarcity that allows to maintain the value of the token at attractive levels and at the same time provides an additional opportunity for passive income. However, the execution of this strategy is limited to the total burning of 500,000,000 tokens, leaving the **Total Supply** around 1,000,000,000 tokens at the end of its implementation.

Due to this finding, **Symplexia Labs** prioritized the development of a *Monetary Policy* that aims to mitigate the negative result of these actions on the price of the PLEX-F token.

Trading cryptocurrencies carries a high level of fraud and scam risks, mainly because that market is full of traps that come disguised as high profitable investments. In this context, the PLEX-F platform provides a set of methods that allow an efficient monitoring of suspicious activities, allowing *Treasury Analyst* to act preventively in the mitigation of malicious activities, and may even temporarily put an account in a *Warning List* in order to correctly assess the nature of those activities. In very exceptional cases, where serious systemic failures are observed, the contract may be temporarily paused by the *Compliance Auditor* so as to correct these eventual failures, thus avoiding financial losses for investors.

And most importantly, to mitigate the trust related risk (insider fraud), the activities of the *Treasury Analyst* and the *Compliance Auditor* focus on different aspects of the contract and are supervised by a *Financial Manager*, who in turn is under the supervision of the *Contract Manager*.

ECOSYSTEM EXPANSION



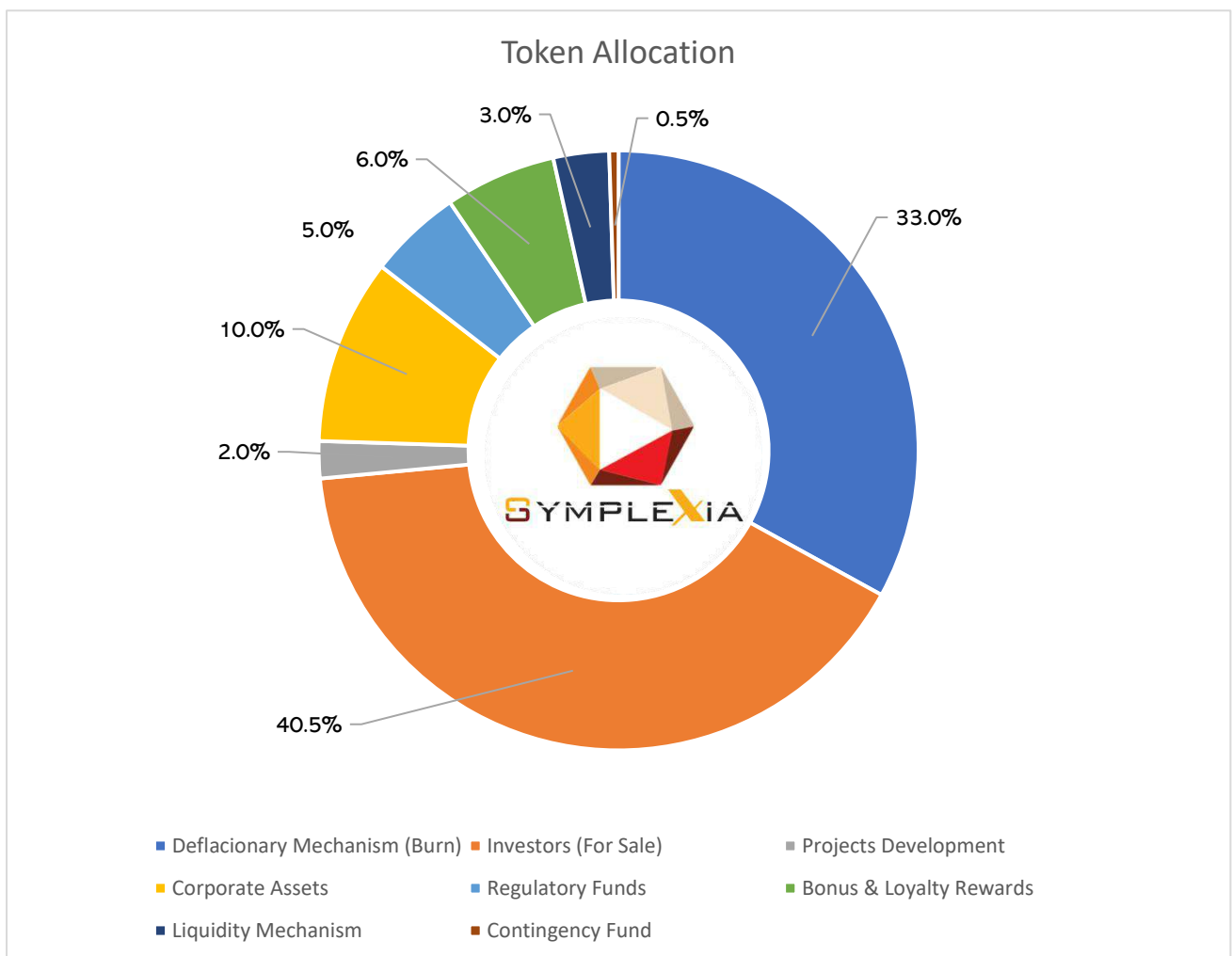
Q3 2023
